

2019-2020 ACADEMIC YEAR FALL SEMESTER ENROLMENT ANNOUNCEMENT – FINANCE

To complete your Registration, you need to pay the full tuition for the 1st semester and show a receipt of payment from the bank (original or copy of electronic receipt) to the Registrar and Student Affairs Directorate during the Registration period. Students who fail to make payment in compliance with these procedures, will not be able to enrol.

ACADEMIC YEAR - TUITION INFORMATION

Tuition is the same for all undergraduate programs at Koç University, excluding the Faculty of Medicine. Tuition figures exclude discounts, but include VAT.

Academic Year tuition for School of Medicine is 26.500 USD or 133.000 TL. School of Medicine students that have been awarded 50% scholarship and who will study in ELC (English Language Center) shall pay 50% of the undergraduate tuition for the ELC year.

After your first semester as a student you will be supported by the International Community Office (ICO) to obtain your Student Residence Permit and Tax Number.

With these documents you may be able to open a bank account in Turkey and at Yapı Kredi (there is a Yapı Kredi bank branch on our main campus) so that you can benefit from payment in installments from your second semester onwards.

Important notes regarding payment in installments:

- Applications should be made to the Yapı Kredi and Koçfinans institutions no later than by Friday, August 23, 2019.
- As internal assessment processes of these institutions take time, it is important that the transactions are started as soon as possible and completed by the end of the enrolment period.
- It is important that the installment payments are deposited into the account that is stated by the financial institutions who provided the loan. Daily interest can be accrued to these amounts which are not deposited into the account specified by the financial institutions.
- Parents preferring the installment payment option must select only one of these financial institutions: Yapı Kredi Bankası or Koç Finans. In case of approval by both institutions, double payment shall occur.
- Along with the installment payment schedule presented to you by Koç University, you are also entitled to use "Education/Personal Finance Loan" with various maturity and payment terms from any financial institution you prefer. However, this amount should be paid completely to Koç University.

Discounts

The types of payment discounts applied to tuitions are as follow;

- 10% to the children of those who are currently employed in the Koç Group companies (cannot be used along with Koç High School, Koç Retirement and Koç Group discounts)
- 10% for the children of parents who have retired after working for 20 years in Koç Group companies. Partial discount will be calculated on a yearly basis for the children whose parents retired after working 11-20 years (cannot be used along with Koç High School, Koç Retirement and Koç Group discounts)
- 5% is applied for each student during the period in which the siblings study together in Koç University.
